### B. Advisory Committee

An exclusive Advisory Committee has to be set up under the Chairmanship of Managing Director, KITS and members from Industry and Academic to monitor the progress of the incubation center and assess the impact & outcome of the CIET from time to time. The Advisory Committee shall also recommend the release of grants to the CIET. The first tranche will be released after signing the MOA for continuation of the incubation program and the subsequent tranches would be based on the recommendation of the Committee.

Any deviation in the expenditure under the budget heads are not permitted unless it shall be approved by Governing Committee / Advisory Committee.

The Governing Committee / Advisory Committee will be periodically reviewing and monitoring the CIET on matters relating to implementation and outcomes. All the action plan calendar of events of the CIET shall be approved by Advisory Committee on a quarterly basis, before launching the programs.
